CONTEST RULES

SOBEYS PLATE-OFF'S CONTEST 2020 (the "Contest")

1. Eligibility

The Contest is open to legal residents of all provinces of Canada except Quebec (the "Participating Provinces") who have reached the age of majority in their province of residence on the date that they entered the Contest. Void where prohibited by law. 3. How to Enter

Option 1:

No purchase is necessary. Valid Twitter account required to participate. Vote for one or more of our Plate-off tweets on Twitter._Each Contest Round will offer a specific number of Plate-off match-ups, which will be tweeted by Sobeys on Twitter. (See chart in Section 2 for the specific number of Plate-offs available in each Contest Round).

Follow the steps below to complete your entry:

- a.) Step 1: On each Plate-off tweet, Entrants will vote on a dish by selecting 1 of the 2 dish options presented.
- b.) Step 2: Once you have selected your dish, a tweet response will be automatically generated. You must post this tweet. This will count as one (1) entry and will be posted to the entrant's Twitter feed. Modifying the tweet in any way will disqualify the entry. Each vote is equal to one (1) Contest entry. Limit one (1) vote, per Plate-off match-up.

9. Winner Contact Details
